



## Pershore Education Planning Area Consultation

Throughout 2020/21 all Pershore schools, Multi-Academy Trusts (MATs), the Diocese and the Local Authority collaborated to find solutions to manage the uncertainty and concerns of schools across the area.

In July 2021 all of the schools and Multi-Academy Trusts confirmed their agreement and intentions to consult on the proposed change to a two-tier Education Planning area, to seek changes of age range (where necessary) and in the instance of the Middle Schools amalgamate with the First Schools.
